Introduction of Merit Increment Scheme in the Public

It has come to the attention that notwithstanding what is stated at paragraph 7 of my circular no. 24/1986 dated 3rd November, 1986, the Heads of some Agencies still do not fully understand the restriction placed in relation to the percentage of the actual 1986 wage bill which could be used to make payment of merit increments in 1986. In the circumstances, it has been decided that the following should be done immediately:-

- (a) the reporting instructions outlines at paragraph II of circular no. 24/1986 dated 3<sup>rd</sup> November, 1986, should be amended by substituting the revised Appendix II overleaf for Appendix II mentioned therein;
- (b) the revised Appendix II should be completed and submitted to the Secretary to the Treasury with copies to the Permanent Secretary, Public Service Ministry, the Accountant General and the Chief Planning Officer, State Planning Secretariat, as soon as the assessments have been completed and you are in a position to determine the total amount to be paid out as merit increments in 1986 to the workers in your respective agencies;
- (c) No actual payment of merit increment is to be made by any Agency unless the above mentioned return is submitted and approval to pay is received from the Secretary to the Treasury.
- 2. I should be grateful if you will arrange for the appropriate officers in your Agencies to note the abovementioned changes and to ensure strict compliance.
