Statistics on Union Dues / Agency Fees in the Public Service.

Further to my Circular No. 14/1989 dated 11<sup>th</sup> May, 1989, on the subject "Restoration of check-off system of Union Dues and Agency fees for the Guyana Public Service Union, I have to inform you that the Public Service Ministry needs to maintain up-to-date statistics relating to the various Unions representing Public Servants in the <u>traditional Public Service</u>. The information required from your Agency is as follows: -

- (a) The number of employees in the bargaining unit of each Union paying Union dues, Agency fees or nothing;
- (b) The total number of employees in the bargaining unit of each Union;
- (c) The number of employees recruited prior to 1976-03-01 who pays nothing;
- (d) The rate of Union dues remitted to each Union every month;
- (e) The rate of Agency fees remitted to each Union every month.
- 2. The above information must be submitted in accordance with the format shown in the Appendix. The total number of employees entered under Column 3 (i.e. number of employees in bargaining unit of each Union) should be the same as the number of employees on the staff list of your Agency.
- 3. Please note that you should also provide similar information in respect of any Union / Association to which Union dues / Agency fees are being remitted, but which has not been reflected in the Appendix. Information concerning project employees should be shown separately.
- 4. You are required to ensure that the above data are compiled and submitted to this Ministry not later than 1989-06-20, and by the twentieth (20<sup>th</sup>) day of each successive month. Your full co-operation and adherence to the abovementioned deadlines will be appreciated.
